RETURNS AND WARRANTIES

Returns will be accepted on the following basis:

- Goods shipped in error

The following conditions will also apply:

Returns

- Tactical Solutions Corporation Ltd must be contacted prior to the return of any goods for a RAN (Return Authority Number). Returns will not be accepted without this number
- A Tactical Solutions Corporation Ltd Invoice Number must be provided with the returned goods
- Display goods, misused or worn goods will not be accepted as returns
- Advice on goods to be returned must be brought to the attention of Tactical Solutions Corporation Ltd within 7 days of the receipt of the said goods
- Returned goods will be subject to a re-stocking fee of 20% of the purchase price. Returned goods must be in the original condition and packaging
- Goods shipped in error by Tactical Solutions Corporation Ltd will not be subject to a re-stocking fee
- Credits will only be issued once the goods have been returned and inspected by Tactical Solutions Corporation Ltd
- Returns with freight charged at Tactical Solutions Corporation Ltd's cost will not be accepted without prior permission
- Where goods appear to be damaged or missing The Purchaser must contact the carrier and Tactical Solutions Corporation Ltd immediately.
